#### **NOTICE TO ALL CUSTOMERS**

### **FHA Annual Mortgage Insurance Premium Reduction**

Florida Capital Bank, is pleased to align with <u>Mortgagee Letter 203-05</u> that announced FHA's reduction of the Annual Mortgage Insurance Premium (annual monthly MIP) rates by 30 basis points (0.30%) on mortgages endorsed for insurance by FHA on or after March 20, 2023.

#### **Broker Transactions**

FLCBank accepts FHA loans "registered" with the reduced premium amount as of March 1, 2023.

## **NDC Transactions**

FLCBank will accept FHA loans "finaled" with the reduced premium amount as of March 1, 2023.

# **Correspondent Transactions**

FLCBank will purchase FHA loans with reduced premium amounts as long as the FHA endorsement date is on or after March 20, 2023. FHA loans endorsed prior to March 20, 2023 must use the "current-higher" premium.

The reduced Annual Mortgage Insurance Premium (Monthly MIP) effective with FHA endorsement date on or after March 20, 2023 is identified in blue font
