Automated Borrower Payment: Within a few minutes after the appraisal order is accepted by the vendor, a payment link will be sent to the email address entered on the appraisal order in Mortgagebot.

Important: The appraisal fee will populate from the AMC Pricing/FLCBank AC Panel Pricing Schedule posted to the Resource Center. The LO must utilize the appropriate Pricing for the Loan Estimate in advance of placing appraisal orders. Reminder to review the Pricing **for add on fees**, for example complexities and/or rush fees as these fees are not included.

- Once the payment screen launches you will be required to enter the property address then click submit
- The credit card section will open; enter the **company** credit card information then click submit

Once payment information has been entered, no one can enter additional credit card information even if they try to access the link. This is to avoid duplicate charges.

Important: If the payment has not been received within 24 hours then the order will be placed on hold. An email notification for 'Hold' will be sent and the Status Log on the Order Appraisal Screen will reflect a status of 'Hold'. Failure to pay promptly will result in either a delayed delivery date or cancellation of the order if not paid within 7 calendar days.
