

VISA & EAD Cheat Sheet

This document is not intended to be used as a complete representation of FLCBank's program and product eligibility requirements for these types of borrowers.

This document contains the list of eligible Visa types and Employment Authorization Document (EAD Card) for loans where borrowers are Non-Permanent Resident Alien. Any Visa categories, types, or EADs not listed below are generally not acceptable to FLCBank.

Regardless of acceptable Visa/EAD documentation, all borrowers must meet the loan program and product guideline for which they have applied including the continuity, stability, and dependability of income requirements. *Please refer to the product guides for more details.*

<u>Conventional and Jumbo Loans</u>: If less than 6 months from loan closing remain on the Visa and/or on the EAD, evidence of prior renewal, or copy of the visa extension is required.

<u>Government Loans</u>: **For FHA Case Numbers assigned on or after May 25, 2025**: Non-Permanent Residents are not eligible for FHA-insured financing.
